

# BURSA KNIFE FESTIVAL STAND APPLICATION TERMS

Participants who wish to open a stand at the festival must comply with the rules stated below, complete their applications within the specified period, and accept all conditions in this form.

## Application and Schedule

- **Registration Deadline:** Applications must be submitted by **Friday, April 17, 2026, at 17:30** via the application file at [www.bursamuze.com](http://www.bursamuze.com).

- **Festival Dates:** Assigned stands must remain open and operational by the authorized person on **May 1-2-3, 2026, between 10:00 and 20:00.**
- **Daily Attendance:** Stands cannot be opened for single days or part-time during the festival.

## Fees and Responsibilities

- **Stand Fee:** A total fee of **5,000 TL** will be charged. Travel, accommodation, and meal expenses are the responsibility of the participant.
- **Sales & Taxes:** The stand owner is obliged to provide customers with receipts, invoices, etc. The Museums Branch Directorate is not responsible for any tax or financial audits.
- **Liability:** Participants are solely responsible for their sales. Bursa Metropolitan Municipality Museums Branch Directorate does not act as an intermediary.
- **Damages:** The participant agrees to pay for any damages caused to the organization area without any conditions.

## Stand Specifications and Rules

- **Concept:** All collections, gifts, decorative, and artistic products must fit the **knifemaking concept**. Stands found to be non-compliant during inspections will have their authorization revoked.
- **Stand Setup:** Each participant is responsible for the design and arrangement of their assigned space.
- **Equipment Provided:** Festival stands are **6 m<sup>2</sup> (3x2 m)**. The organization will provide:
  - 1 Electrical outlet
  - 1 Table
  - 2 Shelves
  - 2 Chairs
- **Personal Application:** Stand applications must be made in person.

## Security and Rights

- **Security:** Participants accept all security measures, including bag and body searches conducted by the organizer and security teams.
- **Media Rights:** Bursa Museum reserves the right to use photographs and videos of participants in promotional materials.

- **Transfer Rights:** If a participant cannot attend, they may transfer their contract to a third party who meets all criteria, provided they notify the organizer at least **7 days** before the festival starts.
- **Organizational Rights:** Bursa Museum reserves the right to change the content, rules, or flow of the event, or to cancel/postpone the organization.

### **Data Protection (KVKK)**

Bursa Museum collects and processes personal data in accordance with **Law No. 6698 (KVKK)**. Data may be used for marketing purposes (special offers, discounts, etc.). Participants may opt-out of electronic communications at any time by emailing **bursamuze@bursa.bel.tr**.

### **Declaration of Commitment**

By signing this agreement, you agree to the following:

1. To be personally present at the assigned stand on **May 1-2-3, 2026, between 10:00 and 20:00**.
2. Not to make any additions or extensions to the standard stand dimensions provided.
3. Not to change the location of the stand determined by the committee.
4. Not to keep any electrical or gas-powered heaters, cookers, or similar devices in the stand area.
5. To wear the official festival ID badge visibly at all times during the event.
6. To receive the assigned equipment at **10:00 on May 1, 2026**, and to return the assigned materials (stand/table) to the authorities with a signature upon the conclusion of the festival on **Sunday, May 3, 2026**.
